Area Planning Restart

The Department of Education has confirmed that operational aspects of area planning may resume. This follows a hiatus in area planning activity as Department of Education staff were redeployed in the New School Day project.

On Wednesday, the GBA attended a meeting with the Area Planning Steering Group which was chaired by the Education Minister. At the meeting Peter Weir outlined priority areas for the remainder of the strategic area plan, including composite classes and small sixth forms.

EU Exit Workshop



GBA has been engaging with the Education Authority regarding the provision of a briefing on EU Exit and what it will mean for employers. The online briefing session will:

- outline the employers obligations as they relate to EU exit and eligibility to work checks;
- provide an update on the approach that the EA is taking which could be adapted by schools; and

Special Educational Needs - DE & EA Consultations

The Department of Education has been working to develop a new improved and more responsive SEN Framework. The new SEN Framework is made up 3 elements:

- The Special Educational Needs and Disability Act (Northern Ireland)
 2016 (the 2016 Act).
- New SEN Regulations.
- A new SEN Code of Practice.

Two separate consultations opened on the 30th September 2020 and will be available until **5pm on 22nd December 2020**:

- 1. <u>Consultation on draft SEN Code of Practice</u> which translates the new draft SEN law into clear and practical guidance for those involved in identifying and assessing children who have, or may have, SEN and for those who provide special educational provision for children with SEN.
- 2. <u>Consultation on draft SEN Regulations</u> which will support the primary legislation.

The new Regulations provide the detailed processes and timescales to be followed by Boards of Governors, the Education Authority (EA) and health and social care authorities to carry out their statutory duties to identify and assess if a child has, or may have, special educational needs and to put in place special education provision for those children who have SEN.

As the body with statutory responsibility for securing provision for pupils with SEN, the Education Authority has now commenced consultation on two frameworks which set out the vison, rationale and delivery plans for SEN provision across Northern Ireland. Views are sought on:

- 1. The Draft Framework for Specialist Provision in Mainstream Schools which focuses on increasing the number of specialist provisions in mainstream primary and post primary schools. This framework also contains a proposal to pilot a new process to significantly speed up the establishment of specialist provision in mainstream schools.
- 2. The Draft Special Schools Area Planning Framework which advocates a consistent model across all areas of Northern Ireland that would see all special schools provide 3-19 provision in the same school.

The EA consultations will close at 5pm on the 11th of December 2020.
