GBA News - August 2018



School Finance Survey

Aware of the financial challenges facing schools in recent years, the GBA issued a survey to member schools in June 2018. The data collected was used to help inform meetings with key political decision makers. The GBA has already met with Department of Education Permanent Secretary, Derek Baker,

and meetings with political party education spokespeople are scheduled in September. The data collected ensured an evidence-based approach to our advocacy work.

Some of the key findings from the survey can be seen below:

- 28 respondents indicated that they operated at a deficit in 2017-18.
- 9 of these schools were operating at a deficit greater than £100,000.
- 35 respondents indicated that they will operate at a deficit in 2018-19.
- 23 of these schools will be operating at a deficit greater than £100,000.
- 19 schools reported that they made redundancies in 2017-18.
- Respondents indicated that there were 50 redundancies made in 2017-18 (teaching and non-teaching).
- 20 schools reported that they were impacted by the apprenticeship levy.
- Levels of the apprenticeship levy to be paid my member schools varies from £666 £24,000.
- 3 schools reported a decrease in funding from the Extended Schools Programme.
- 1 school reported that they will no longer receive extended schools' funding of £22,000 per annum.
- Payroll costs as a percentage of the LMS budget increasing year on year.

The GBA would like to thank all the schools who responded to the survey. The information gathered will also be used in our submission to the Northern Ireland Affairs Committee inquiry into education funding.

Westminster Inquiry - Education Funding

The Northern Ireland Affairs Committee is conducting an inquiry into education funding. The GBA has welcomed the inquiry given the absence of Executive and Assembly and will be providing evidence. The committee is seeking views on the following questions:

- Are the funds allocated to the Department of Education in the Northern Ireland Budget Act 2018 sufficient to improve educational outcomes in Northern Ireland?
- How should the UK Government manage additional funding earmarked for education as part of the confidence and supply arrangement?
- Are levels of capital funding sufficient to support investment in improvements to Northern Ireland's schools?

- What are the areas of greatest need in the education sector in Northern Ireland?
- How can funding be best deployed to ensure value for money in education spending?
- How can funding be used to support the different school sectors in Northern Ireland, including schools for children with special educational needs and disabilities?

Derek Baker Meeting

The GBA met with Derek Baker, Department of Education Permanent Secretary, and senior officials in July to highlight concerns over the education budget. At the meeting the GBA used findings from the financial survey to inform discussion regarding the precarious state of school finances. The GBA also raised concerns regarding the level of funding for schools operating across split sites and called for this to be re-examined by the Department. Other items on the agenda included area planning and minibus licensing. The meeting with Derek Baker is part of the GBA's continuous engagement with senior officials and party representatives to address levels of funding for front line education provision.
