This week the Education Committee received a briefing from the Minister on school restart. The Minister emphasised that education has never stopped and has continued remotely, and tribute was paid to school staff for their work and dedication. Topics discussed included COVID-19 mitigations, school transport, clinically extremely vulnerable pupils and lateral flow testing. You can view the session [here](#).

## CCEA Update

---

We received the following information from CCEA and have been asked to share this with our schools:

On 6 January 2021, the Minister of Education, Peter Weir MLA, cancelled all CCEA GCSE, AS and A2 examinations scheduled for January, February, May and June 2021. Instead, by Formal Direction of the Minister dated 2 March 2021, the approach to awarding grades in Summer 2021 will be based on teacher professional judgements, with moderation.

Since the announcement, CCEA representatives have worked with all schools, including voluntary grammar schools to provide the necessary advice and guidance to support implementation of alternative arrangements for awarding Summer 2021 and the voluntary grammar schools have engaged meaningfully throughout. CCEA has developed a five-step process, which is set out in the document, *GCSE, AS and A Level Awarding Summer 2021: Alternative Arrangements – Process for Heads of Centre*. Discussions with schools, including those in the voluntary grammar sector will continue as teachers and school leaders prepare for the submission of Centre Determined Grades for each student.

As part of the support package for Summer 2021, CCEA partnered with the Chartered Institute of Educational Assessors (CIEA) to deliver a programme to schools and colleges to support fairness and consistency in alternative awarding arrangements. This programme was optional; however, it was designed to help centres develop a shared understanding of the process of arriving at judgements and reinforce existing knowledge and understanding in assessment. On completion of the training, attendees should act as Lead Assessors in their centre and disseminate the content of the programme to colleagues. Their role will be in quality assuring the process required to produce fair and robust judgements for Summer 2021. The training programme was comprised of the following four modules:

- The Validity Chain;
- Standardisation and Moderation;
- Using Data; and
- The 2021 Process.

CCEA subject-specific guidance and subject-specific webinars will also be

provided to support centres at Head of Department and subject teacher level. The support guidance and webinars will reconfirm earlier examination policies, such as the omission of units at GCSE and A level. They will also include information on how to adapt CCEA assessment resources to manage content not covered due to COVID disruption, grade descriptors and determining grades that do not have grade descriptors, using the CCEA assessment resources and application of mark schemes.

Access will also be provided to existing support which may be used in checking understanding of qualification standards (demand and performance), such as past papers, mark schemes, grade boundaries, Chief Examiner's reports, Principal Moderator's reports, agreement trials, exemplification of examination performance, CCEA Analytics and specimen assessment materials.
