

Landscape Review Launch and New Framework for 14-19 Education & Training

The Department of Education has published an independent 'Landscape Review' of the Education Authority. The Review was undertaken on behalf of the Department by the consultancy firm Baker Tilly Mooney Moore. Its purpose was to consider the overall operation and governance of the EA, and the extent to which it is effectively able to deliver against stated Executive and Departmental priorities. The report makes 13 recommendations and is available here.

Also launched this week was a joint framework from Education Minister, Michelle McIlveen and Economy Minister, Gordon Lyons, to help drive forward a more strategic approach to education and training for 14 to 19 year olds. More information is available here.

Following the dissolution of the General Teaching Council for Northern Ireland (GTCNI), the Education Minster has announced that her Department is consulting on the functions currently assigned to the GTCNI and how these can be delivered efficiently and effectively.

The consultation launched on 13th June and closes on 30th September 2022 and will provide the teaching profession, wider educational system and stakeholders with the opportunity to consider the structures used in other jurisdictions and the differing functions these bodies provide. Area Planning Update

- Education Minister Michelle McIlveen has approved a number of Specialist Provisions in Mainstream Schools as part of a Special Educational Needs (SEN) Area Planning pilot exercise. The pilot includes the simultaneous provision of 128 Specialist Provisions across 58 schools.
- The Strategic Area Plan and Special Education Strategic Area Plan 2022-2027 are planned for launch at the end of June 2022, along with the first Operational Plan which will run from September 2022 to August 2024.
