# DE Equality Impact Assessment Consultation -GBA Response

The GBA recently responded to the Department of Education's equality impact assessment consultation, outlining the impacts of budget cuts on voluntary grammar schools and the wider education system. Despite voluntary grammar schools being amongst the most sustainable schools in NI, the GBA has grave concerns regarding the future sustainability of the NI education system due to over a decade of real terms budget cuts, and reductions to this year's budget and capital investment.

There is a clear need for increased funding levels for the day-to-day running of schools to enable them to fulfil their statutory duties and provide additional support to vulnerable pupils, as highlighted in the <u>response</u>.

## **GBA Learning Exchange Visit**

The GBA is participating in a learning exchange visit to Wales, planned for the end of September 2023, and facilitated by the <u>North West Migrants' Forum</u> as part of their "Black Heritage in NU: Hidden History" project.

The project aims to shed light on the significant contributions of Black individuals to the history of NI, and systemically introduce Black History into the local curriculum, as well as creating a book on local Black history, and hosting an exhibition on Black History.

You may be aware that Wales has mandated Black history lessons across its national curriculum. The learning exchange visit aims to help participants understand the processes undertook by Wales to embed black and minorised histories in their education curriculum through school visits and conversations with key stakeholders.

We will share our experiences from the visit with you in future newsletter editions.

## All Ireland Scholarships 2023

The All Ireland Scholarship Scheme which is funded by JP McManus provides financial support to high achieving students from low income households.

The scholarship offers students financial support of £5,500 per annum for the duration of their course.

**Twenty five** scholarships will be awarded to students who attend a grant aided post primary school or a Further Education College in Northern Ireland.

- Nineteen Scholarships will be awarded to the top 'A' Level students from grant aided Post Primary Schools. A minimum of two Scholarships will be offered in each county based on where students live.
- Six Scholarships will be awarded to the top Level 3 Extended Diploma students from Further Education Colleges. One Scholarship will be awarded in each of the six Further Education Colleges.

Applicants must have been in receipt of the Education Maintenance Allowance (EMA) at the time of examination, and due to commence an undergraduate course in university in the academic year of 2023/2024.

The deadline for receipt of applications is **4pm on Thursday 31 August 2023**.

Specialist Provision in Mainstream Schools

#### Background

<u>Specialist provision in a mainstream school</u> provides a modified learning environment with an enhanced Pupil Teacher Ratio (PTR) suited to a pupil's learning profile. Pupils, where appropriate, also benefit from experiencing a level of inclusion, commensurate with their level of need, within mainstream classes.

#### Planning

The Education Authority has taken forward a number of consultations over the last two years as part of the new, more agile, process for establishing specialist provision in a mainstream setting (i.e. without the need for a Development Proposal).

The Area Planning Local Groups, chaired by the EA, will soon be reconvening to discuss areas where there are pressures for SEN places and to plan for provision in September 2024 and beyond. # Open Consultation: Strategic Framework to End Violence Against Women and Girls

The Executive Office are leading on the development of a Strategic Framework to End Violence Against Women and Girls.

This draft seven-year (2023-2030) Strategic Framework, has been co-designed with over 50 stakeholders from across government, community and voluntary sectors, and wider society, including those with lived experience, and builds on the evidence received and the key issues identified through the Call for Views process. This took place in 2022 and includes feedback from members of the GBA Executive Committee.

The consultation takes views on:

- The Strategic Framework to End Violence Against Women and Girls
- The foundational Action Plan

04 July 2023 to 03 October 2023.

The responses received will be considered by the EVAWG Directorate alongside evidence gathered during our wider stakeholder engagement. The proposals for the Strategic Framework and Foundational Action Plan are subject to the views of the Executive who will be responsible for final approval.
