## NIAO Governance Guidance Published

A new Audit Office guide on best practice in School Governance has been launched by Northern Ireland's Comptroller & Auditor General, Dorinnia Carville, the Permanent Secretary of the Department of Education, Dr Mark Browne, and Chief Executive of the Education Authority, Sara Long.

The Northern Ireland Audit Office (NIAO) guide was developed in recognition of the challenges facing Board members who, while volunteers acting in an unpaid capacity, are accountable to the Department of Education or Education Authority for their use of public money and for ensuring the best outcomes for learners.

## **DE Publishes Corporate Plan**

The Department of Education has published Every CHILD, its Corporate Plan for 2023-28 which puts children and young people at the centre of its strategic

priorities.

At the heart of the plan is the Department's new vision that "Every child and young person is happy, learning and succeeding" and is underpinned by five new child-centred strategic priorities.

Speaking following publication of the plan, Dr Mark Browne, Permanent Secretary of the Department of Education, said: "I believe this plan sets out an ambitious and transformative programme of work for the next five years...It is also my hope that the importance of education in our society will be recognised through the commitment of the necessary future investment to support the pursuit of our ambitious vision."

# **GBA Meeting to Discuss Student Mobility**

Following the Economic and Social Research Institute's <u>recently published</u> <u>report</u> on Student Mobility in Ireland and Northern Ireland, the GBA met with Professor Pol O Dochartaigh, Chairperson of the Universities Ireland Working Group, established to look at barriers to student mobility, to highlight the inequities and barriers facing applicants applying to undergraduate courses.

Changes to the CAO Common Grading scheme and the equivalence of three A Level grades with Leaving Certificate results are under consideration. The GBA also urged HEIs to improve communications with CEAIG staff to disseminate up-to-date information and materials.

Pupils, where appropriate, also benefit from experiencing a level of inclusion, commensurate with their level of need, within mainstream classes.

## **Live Consultations**

Integrated Education Act Action Plan: 31st August 2023 - 31st October 2023

The Integrated Education Act (Northern Ireland) 2022 became law on the 26th October 2022, placing a duty on the Department of Education (DE) to prepare,

publish and maintain a strategy for integrated education, including an Action Plan to deliver on the strategy.

The GBA has submitted views to the Integrated Education Act Steering Group on the Action Plan and will be submitting a response to this consultation to provide our comments and raise key concerns. **We would welcome your views on the future direction of the plan and encourage schools to respond individually.** 

# Relationships and Sexuality Education (RSE) Consultation: 1st September 2023 - 24th November 2023

The Department of Education has launched a consultation on the circumstances and arrangements which would enable a parent/carer to excuse their child from receiving age-appropriate, comprehensive and scientifically accurate education on sexual and reproductive health and rights, covering prevention of early pregnancy and access to abortion.

Following an analysis of the consultation findings, the Department will publish its overall response to the consultation and develop guidance on the arrangements to have a child excused from specific classes by 1 January 2024.

Statutory Guidance on the Reduction and Management of Restrictive

Practices in Educational Settings in Northern Ireland: 5th September 2023

- 3rd November 2023

The Department has launched a consultation seeking views on its Statutory Guidance on the Reduction and Management of Restrictive Practices in Educational Settings in Northern Ireland.

The Statutory Guidance aims to provide clarity on the use of restrictive and supportive practices in educational settings, with a view to reducing and minimising the use of restrictive practices, wherever possible. The Statutory Guidance makes clear that restrictive practices should only ever be used when it is necessary and proportionate to do so, in order to keep children, young people, and others from coming to harm.



# **GBA Learning Exchange Visits**

### Cardiff, Wales - North West Migrants' Forum

The GBA recently attended a two-day learning exchange to Cardiff, Wales, organised by the North West Migrants' Forum (NWMF) as part of their <u>Black Heritage in NI: Hidden History Project</u>. NI delegates (photographed below) included NWMF staff, representatives from the various NI education sectors, political representatives and academics.

During the trip, delegates met with Welsh Government Officials, academics, and practitioners to learn about Welsh curriculum reform and the work that has been undertaken to help realise aspirations for an education system that develops pupils' understanding of diversity, with all learning areas reflecting the experiences of all citizens from all backgrounds and cultures.

Presenters included Professor Charlotte Williams OBE, Chair of the Black, Asian and Minority Ethic Communities Group of the Welsh Government, who gave us an overview of the work of the group in providing recommendations for reinforcing the teaching of past / present experiences and contributions of Black, Asian and Minority Ethnic communities across Wales.

We also visited Cardiff and Vale College, and St. Paul's Church in Wales Primary School to hear about their implementation of the curriculum, challenges faced and the progress that they have made in imbedding an anti-racist curriculum.

The NI delegates will meet again in December to explore how we can use our knowledge gained in Wales to contribute to the development of an anti-racist Northern Ireland.

### Shared Education Stakeholder Forum

The Shared Education Stakeholder Forum, led by the Department of Education and the Education Authority, met this month to discuss various pertinent matters including:

- The exploration of new partnerships as well as the enhancement of existing partnerships.
- Overcoming barriers to Shared Education, e.g. restrictive funding models.
- Moving beyond the concept of Shared Education as a mechanism of bringing together two communities, traditionally associated with NI, and looking at a more multicultural, multifaceted model.
- Greater synchronisation of Shared Education with Area Planning.
