DE publishes EQIA on final budget allocations for 2023-24

The Department of Education recently conducted a budget Equality Impact Assessment Consultation (EQIA) and has now published their <u>final report</u>, taking into consideration all the responses, and issues raised to inform further in-year allocations if more funding becomes available.

Significant decisions already taken by the Department's Permanent Secretary include reductions in the EA's Aggregated Schools Budget (ASB) and Block Grant and the cessation of the Engage, Healthy Happy Minds and School Holiday Food Grant schemes.

While this is the Final EQIA report on the 2023-24 Resource Budget, the Department will continue to welcome any comments you may have in terms of the EQIA and the recommendations with regard to measures to mitigate adverse impact or alternative policies. Integrated Education Act Action Plan: 31st August 2023 - 30th November 2023

The Integrated Education Act (Northern Ireland) 2022 became law on the 26th October 2022, placing a duty on the Department of Education (DE) to prepare, publish and maintain a strategy for integrated education, including an Action Plan to deliver on the strategy.

The GBA has submitted a response to the consultation outlining key matters in relation to the proposed the action plan, including:

- Measurement of demand for school places should be in the context of all education sectors.
- Parity of access to services and Teacher Professional Learning for all schools.
- Effective use of public funding.

- Area Planning and the sustainability of the school estate as a whole.
- Definition of integrated education and acknowledgment of levels of integration in schools across all sectors.

Area Planning - Operational Plan 2 and Specialist Provision Classes

Operational Plan 2: 2024-26 - Planning

The Area Planning Local Groups reconvened in September to analyse future need and develop workstreams for Operational Plan 2: 2024-26 (click <u>here</u> for more information on Operational Plans). The last meeting before the Christmas break will be a Joint Locality meeting on Thursday 7th December to brining together the representatives from all sectors to finalise the workstreams of Operational Plan 2.

As part of the Area Planning process, it is essential that these conversations take place during the planning year, in advance of the publication of Operational Plan 2.

Specialist Provision in Mainstream Schools - Current and Future Pressues

Work is also ongoing to identify current and future pressures for school places for pupils with Special Educational Needs. The number of pupils requiring a place in a specialist classroom within a mainstream school is rising and is set to continue to rise in the coming years, with a particular pressure identified for post-primary, as large numbers of children with additional needs make their way through the primary phase.

<u>Specialist provision in a mainstream school</u> provides a modified learning environment with an enhanced Pupil Teacher Ratio (PTR) suited to a pupil's learning profile. Pupils, where appropriate, also benefit from experiencing a level of inclusion, commensurate with their level of need, within mainstream classes.
