GBA School Finance Survey - Spring 2025



Our 2025 School Finance Survey which will open on **1st April and close on 10th April 2025** will ask relevant questions in order to understand the financial health of the Voluntary Grammar sector at the close of the 2024/25 financial year.

In particular we are keen to get information on current issues including the impact of the teaching staff pay award in 2024 and the impact of the pay and grading review for support staff.

A link to the Spring 2025 survey will be sent to Principals and Bursars next week. We really appreciate your time and support with this to enable us to gather this information.

The information provided will not be attributed to any individual school but will help develop an overall picture of the financial position of the sector. We will use the information gathered in future engagement with the Minister and relevant officials in the Department and EA.

Minister Launches New Education Strategy

The Education Minister recently announced the launch of a new strategy "TransformED", which is designed to reform and improve education delivery in
Northern Ireland.

There will be a renewed focus by the Minister within the current assembly mandate (2022-2027) on:

- Curriculum
- Assessment
- Qualifications
- Tackling Educational Disadvantage
- School Improvement
- Investment in Teacher Professional Learning

Reform in each of these areas will be underpinned by significant investment in high-quality teacher professional development.

There is also a focus on longer term reform, as set out within the recommendations of the Independent Review of Education, including the following areas:

- Invest in Early Years
- Transform SEN support
- Raise compulsory education and training age to 18
- Improve education support services

A detailed implementation plan to support the strategy will be published in Spring 2025, identifying lead organisations and delivery mechanisms, as well as funding requirements.

Following publication of the implementation plan, the Department will report at key milestones through an annual progress report.

The Wolfson Foundation - Funding Opportunities for Post-Primary Schools

The Wolfson Foundation support high-achieving state-funded secondary schools and sixth form colleges to improve the teaching at GCSE and A-Level of subjects that need specialist spaces and equipment.

Grants are awarded towards capital projects that help schools to create and improve these facilities.

Your school should:

- be state funded
- have at least two years of exam results available
- have been inspected by ETI and have an overall outcome of 'Good' or above
- be able to demonstrate an achieved level of excellence OR significant progress towards excellence through, for example, inspection reports and progress made by students
- if a predominantly denominational or faith-based school, it should have a non-discriminatory entry policy in respect of religious allegiance with at least 10% of pupils of other denominations, faiths or none.

In assessing the excellence of a school or college, the Wolfson Foundation also considers the local context, including deprivation measures and previous Wolfson support in the same region within the last five years.

Your project must:

- cost at least £25,000
- be for new build, refurbishment work or technical equipment
- be focussed on the teaching of one or more of the following subjects at GCSE and A-Level: science, computer science, design & technology, art, languages, music and performing arts

and have **one or more** of the following aims:

- improved quality of teaching and learning spaces for subjects which require specialist facilities and technical equipment
- increased numbers of students taking these subjects
- improved learning outcomes for students taking these subjects.

When to apply:

20 March – 1 May 2025

Decision dates:

Autumn 2025. Projects must not be completed before a funding decision is made.

Area Planning

Specialist Provision in Voluntary Grammar Schools

The GBA recently attended a "SEN First Approach" to Area Planning meeting, Chaired by EA Assistant Director of Sustainable Schools and Community Planning, which provided an overview of the pressures in the coming years regarding SEN placements.

There is an increasing number of pupils in NI who require additional, specialist support in both Special and Mainstream settings and this is set to continue for the foreseeable future.

The GBA is currently engaging with EA Area Planning, EA SEN Colleagues, ETI and our member school Principals to discuss SEN provision in voluntary grammar school settings.

School Uniform Bill - Call for Evidence

As part of the Assembly's legislative processes, The School Uniforms (Guidelines and Allowances) Bill has been referred to the Assembly's Committee for Education so that the Committee can consider and take evidence on the Bill and report its opinion to the Assembly.

A <u>Committee Motion</u> has been tabled to extend this evidence-gathering stage until December 2025 however Committee Members have indicated that they expect it to compete around November 2025 and the implementation of the Bill to commence in September 2026.

In order to inform the Committee Stage of the Bill, the Committee for Education is seeking views from stakeholders on the objectives, proposals and potential consequences of the Bill and is welcoming views/comments on the contents of the Bill.

The closing date for comments is Tuesday 13 May 2025.

The GBA is also developing a response to the Committee highlighting the impact of the Bill on schools and the potential implications for Principals, teachers and Boards of Governors. We will share this with you in due course.

GBA Responds to Budget Consultation

The GBA recently responded to the Draft (2025/26) Budget Consultation to raise issues pertinent to our member schools and the education sector.

Some of the concerns raised included the impact of a rise in employer National Insurance Contributions on school budgets, the funding of public sector pay, the need for capital investment and the addressing of a backlog of maintenance work.
