## **Launch of Public Consultation on Draft "Attendance Matters" Strategy**

---

The Education Minister has launched a public consultation on a new draft strategy to improve school attendance and understand the reasons behind pupil absence.

Although the majority of pupils attend school regularly, there are some who struggle with attendance and the factors behind poor school attendance are complex.

The proposed Attendance Matters Strategy sets out six priority areas to support children and young people to attend school every day:

- Promoting a nurturing environment to understand and reduce Emotionally Based School Non Attendance (EBSNA);
- Ensuring inclusive strategies to promote positive behaviour;
- Using data to identify vulnerable children and young people and delivering early interventions;
- Understanding why children are missing from formal education and taking steps to address this;
- Piloting a whole community approach to improving attendance; and
- Transforming support for schools and settings.

All those with an interest in this issue, particularly families and schools, are encouraged to provide their views.

## **GBA Attends EA CSU "LEAD 10" Event**

---

The GBA recently attended the EA's Controlled Schools Unit ([CSU](#)), "LEAD 10" event in the Antrim Board Centre. At the event, ten controlled school leaders from various education phases and settings, presented examples of best practice from their schools, and spoke about the challenges and opportunities they have experienced during their time as school leaders.

Some of the challenges school leaders spoke about included:

- Recruitment and training of new staff.
- Increase in the number of learners with additional needs and the increasing complexity/ diversity of needs.
- Issues around attendance.
- Improving literacy outcomes.
- Parental engagement
- Mental health and wellbeing of staff and pupils.
- Shared Education.

Leaders also spoke about various approaches taken within their school to improve the educational experience and outcomes for pupils, such as restorative practice, collaborative working with professionals and external agencies, development of student leadership teams and mental health teams, staff mentoring programmes, and upskilling of classroom assistants.

## Specialist Provision in Mainstream Schools

As you will be aware, the Northern Ireland education system is facing significant pressure in securing appropriate placements for children with statements of Special Educational Needs for September 2026/27 and beyond. The EA SEN team recently hosted a series of virtual engagement sessions for primary and post-primary schools, which included information on the support available to voluntary grammar schools in delivering specialist provision.

## Institute of Fiscal Studies - Demographic Change and Schools Across the UK

The Institute of Fiscal Studies recently published a [paper](#) analysing the choices facing policymakers regarding past declines in pupil numbers.

The paper highlights that the number of children across the UK is expected to decline by about 7% or 800,000 between 2025 and 2035 and discusses the challenges that this will bring for the UK education sectors over the next decade and beyond.
